ALTERNATIVE FUNDING SOLUTION FOR SMALL AND MEDIUM ENTERPRISES

The concept of "New Normal", will demand a new and more flexible approach to weather the storm of the pandemic. With Covid-19 hit at the end of 2019, the entire world was caught off-guard by the unprecedented health crisis. In addition to the ensuing panic, the world economy has become virtual since the spread of Covid-19 has single-handedly disrupted the world. In what seems like the blink of an eye, this disease has upturned our lives and our daily activities.

We are seeing many businesses across multiple sectors come to a standstill, delivering a significant blow to the global economy. However, as they say, within every crisis, there is an opportunity. Many of our businesses have drastically changed their business models to stay competitive. The use of technology, mainly to keep their businesses running and connected with the people has made many of us somewhat at a turning point: a make-or-break time.

Industry leaders are finding themselves in a transformational landscape, and are rolling out solutions that will not only help mitigate the impact of Covid-19 but also allow the nation's economy to bounce back from the MCO safely and responsibly.



Over the last few years, small and medium-sized enterprises (SMEs) have stood out as the key driver behind economic development and emerged as an important and dynamic sector for the economy.

According to the Department of Statistics Malaysia (DoSM), SMEs contributed 38.9% (RM 553 million) of the total GDP in 2019, and it is anticipated that the contribution will push to or surpass the 50% mark within the next decade, this is supported with the continued outperformance of the year-to-year SME GDP growth to the total Malaysia's GDP.

The statistic above foresees that Malaysia will soon be driven by the SMEs as the main engine for the economy and as it grows, there is a need to ensure funding options are available and aware of by the SMEs in order for them to continue growing. This sector, if provided with the right support, has the potential to spread industrial growth throughout the country.

For many years, the SMEs have been mainly relying on banks to provide financing for their expansion agenda, and many of them have failed to secure the funding due to the risk associated with SMEs generally, in which banks often avoid. With the current economic recession, arising from the pandemic, the banks are more reluctant than ever to approve financing applications from SMEs.

ALTERNATIVE FUNDING SOLUTION FOR SMALL AND MEDIUM ENTERPRISES



One of the alternative funding solutions that Malaysia's capital market has to offer, is crowdfunding. Crowdfunding as defined in the Cambridge Dictionary, is "the practice of getting a large number of people to each give small amounts of money in order to provide the finance for a business project, typically using the internet". There are four types of crowdfunding; donation-based, reward-based, equity-based (commonly known as equity crowdfunding (ECF), and lending-based (commonly known as Peer-to-Peer (P2P) financing). The first two types do not provide any financial returns to the contributors, nor are they regulated, the latter two are otherwise and they are of concern to this article.

The crowdfunding market has been gaining attraction, especially during this pandemic as it has accelerated the adaptation of digitalisation by all of the relevant stakeholders, crowdfunding offers several value propositions as compared to the conventional financing option, main ones are:

- It takes shorter time to obtain funding through crowdfunding as it does not go through rigorous process as how banks would normally do. However, there are safety measures that are required by the crowdfunding platform operator to undertake to ensure legitima.
- Crowdfunding offers access to larger audience/investors as compared to banks, in which it increases the funding success rate relatively.
- SMEs that seek funding through crowdfunding are required to pitch their businesses/projects to the crowd/investors directly via online crowdfunding platform, which provides an opportunity for the SMEs to leverage on to gain media exposure, especially through social media.
- SMEs that list their business/project on a crowdfunding platform will also get sense of the market reaction towards their business/project. Hence, it would provide opportunity for the SMEs to enhance their operation or change their business strategy depending on the reaction they gets from the crowd/investors.
- SMEs that seek to list their businesses/projects on ECF or P2P platforms will be coached by the platform operators to ensure that the funding target is achieved and also ensure that the SMEs continue to grow. The platform operator does this to increase its rate of successful campaigns listed on its platforms and also in some cases, to manage their own risk as the operators are allowed to invest in the SMEs' businesses/projects directly, but limited to a certain percentage.

ALTERNATIVE FUNDING SOLUTION FOR SMALL AND MEDIUM ENTERPRISES

There are two types of crowdfunding that are regulated by the Securities Commission Malaysia (SC) (under the Guidelines on Recognised Market); ECF and P2P financing. Both of these types provide financial returns to the investors.

The InvestSmart (an investor empowerment body initiated by the SC) defines ECF as "a form of fundraising that allows a start-up or other smaller enterprises to obtain capital through small equity investments using online portals to publicise and facilitate such offers to crowd investors". In short, it refers to mico-funding activitiy targeted at the general public, where in return, the investors (crowd) will obtain portion of the equity of the company/issuer, similar to purchasing stock of a public listed company in Bursa Malaysia. As of January 2021, there were 10 ECF platform operators registered from the SC, and these platforms have collectively raised RM 129.64 million with 119 succesful campaigns (as of 30 September 2020).

P2P financing however, it is defined by InvestSmart as "a leading and borrowing activity between businesses and investors, facilitated through an online marketplace i.e., a P2P financing platform operator.

The funding needs are met by a group of investors putting in small amounts of money for a particular business need that has been vetted by a P2P financing platform operator". In layman's terms, it refers to micro-funding activity funded by the general public/crowd for a specific business/project where investors expect interest/profit in return. As of January 2021, there were 11 P2P platform operators registered with the SC, and these platforms have collectively raised RM 921.83 million with 13,039 successful campaigns (as at 30 September 2020).

ECF or P2P platform operators that facilitate the offering of Islamic campaigns are required to appoint Shariah adviser as stated in Chapter 12 of the Guidelines on Recognized Markets, to ensure the campaign complies with Shariah rules and principles at all times. Currently, there are one from each ECF and P2P platforms that facilitate the offering of Islamic finance campaigns, which are Ethis Ventures Sdn Bhd and P2P Nusa Kapital Sdn Bhd, respectively.

SMEs that are interested may contact the licensed ECF or P2P platform operators directly to understand further. Additionally, the platform operators, normally provide information on successful campaigns which would allow the SMEs to comprehend further and learn from the past experience of others.

Lack of access to affordable funding can easily trap SMEs in a "downward spiral". They are unable to grow without more funds, and they cannot get funds without more growth. One of the ways to help in reducing financing hurdles for SMEs is to strengthen the infrastructure that supports the financial transactions, which includes the laws, regulations, and institutions to create, register and enforce collateral insolvency regime and credit reporting tools. It would also help for the government to develop a credit guarantee schemes for SMEs businesses, private SME lenders, and establish a hometown investment trust funds for financing risky SMEs and start-up businesses.

The lack of SME databases is another challenge for our SMEs. Their financial and non-financial accounts are often difficult to access. Hence, reducing their chances in getting financial loans or any form of finance assistance. Japan has created a Credit Risk Database (CRD) that shows how SMEs can be rated based on financial and nonfinancial data. This CRD will include data that can be used to rate SMEs through statistical analysis. This is something that we should be looking at in helping our SMEs and at the same time keeping track of their business developments.

2025 World Anti-Corruption Conference (WACC)

WACC 2025: United for Integrity: Innovation, Collaboration, and Accountability in the Fight Against Corruption

On 24 October 2025, the World Anti-Corruption Conference (WACC) 2025 built upon prior discussions to deepen engagement on emerging challenges and innovative tools within the global anti-corruption land-scape.

This year's agenda highlighted the application of artificial intelligence in fraud detection, the integration of blockchain for financial transparency, and the critical role of investigative journalism in uncovering institutional misconduct. The conference also examined advancements in multilateral enforcement mechanisms and policy reforms aimed at strengthening public procurement integrity, corporate governance, and cross-border legal cooperation.

With an emphasis on capacity-building, policy-driven dialogue, and international collaboration, WACC 2025 not only addressed the root causes of corruption but also empowered institutions and individuals dedicated to fostering transparency, accountability, and resilience. Through this shared commitment, WACC continued to shape the global anti-corruption agenda and inspire collective action toward a world grounded in integrity.

A highlight of WACC 2025 was the diversity of perspectives brought by speakers for topics below:

Session 1: Corporate Integrity in a Global Marketplace: Compliance Challenges and Strategies Across The Globe

This session addressed the complexities faced by multinational corporations in managing corruption risks and navigating inconsistent regulatory frameworks across jurisdictions. Mr. Colin Mayer CBE, Emeritus Professor of Management Studies, Blavatnik School of Government and Saïd Business School, University of Oxford, moderated the session featuring Dr. Hairuzzaki bin Mohd Yusof, Senior Assistant Commissioner, Malaysia Anti-Corruption Commission; Mr. Yousouf Jhugroo, Chairman and CEO, Compliance and Risk Consultancy (CRC) - Founder, Consumer Protection Bureau (CPB), London; and Dr. Musa Adamu Aliyu, SAN, Chairman of the Independent Corrupt Practices and Other Related Offences Commission (ICPC), Nigeria. The discussion underscored the importance of robust compliance systems, ethical leadership, and cross-border cooperation to strengthen integrity and good governance in global business operations.

Session 2: Financial Innovation and Integrity: Fintech's Role in Strengthening Governance and Accountability

This session examined how emerging financial technologies are transforming the global financial ecosystem while introducing new governance challenges. Professor Saeed Akbar, Head of Accounting, Finance and Economics at the University of Bradford, served as both moderator and panellist, alongside Mr. Mohamad Zakie bin Abu Hassan, Deputy Director, Asset Management Division (AMD), National Anti-Financial Crime Centre (NFCC), Malaysia, and Dr. Janet Bastiman, Chief Data Scientist at Napier Al. The panellists discussed how innovations such as e-KYC, digital identity systems, and mobile payment platforms can enhance transparency and mitigate risks of money laundering and corruption. They underscored the importance of balancing innovation with effective regulatory oversight to preserve financial integrity within a rapidly evolving digital landscape.

Session 3: Transparency by Design: Embedding Ethics and Accountability in Public Sector Digital Transformation

As governments around the world embrace digital transformation to enhance public service delivery, it is vital that transparency, ethics, and accountability are built into the process from the outset. Ms. Chong Tze Wey, Economics and Management student at Exeter College, University of Oxford, moderated the session featuring Mr. Johnston Busingye, High Commissioner of the Republic of Rwanda to the United Kingdom; Mr. Silviu Popa, Former Secretary General, National Integrity Agency, Romania; Mr. Jung-Oh Son, Senior Deputy Director, Anti-Corruption & Civil Rights Commission (ACRC), Republic of Korea; and Ms. Myat Su Thin, Director, Anti-Corruption Commission, Myanmar. The discussion examined how digital infrastructure including e-government platforms, digital identification systems, and procurement technologies can enhance oversight, reduce corruption risks, and strengthen citizen trust. The panellists shared practical approaches to designing integrity-first digital strategies that ensure accountability, inclusivity, and sustainable governance in the public sector.

Session 4: Youth, Ethics, and Digital Citizenship: Empowering the Next Generation Against Corruption Across The Globe

As the digital generation comes of age, young people are reshaping how integrity and accountability are defined, expressed, and upheld. Across borders, youth-led initiatives are harnessing technology, education, and civic participation to advance transparency and ethical governance. The discussion was led by Dr. Omar Hamdan, Senior Lecturer in Leadership and Management at Oxford Brookes University, who was joined by Mr. Wong Wai-Kit, Assistant Director, Independent Commission Against Corruption (ICAC), Hong Kong, China; Professor Vicha Mahakun, Dean, School of Law, Rangsit University & Chairman, Anti-Corruption Foundation, Thailand; and Ms. Bianca Kopp, Coordinator, Global Resource for Anti-Corruption Education and Youth Empowerment (GRACE) initiative, Corruption and Economic Crime Branch, United Nations Office on Drugs and Crime (UNODC). Together, they shared practical experiences on mobilising young leaders as catalysts for change, highlighting the role of education, digital citizenship, and collaboration in nurturing a culture of integrity. The session underscored the power of youth engagement in advancing accountability and shaping a more transparent and ethical future.



2024 World Anti-Corruption Conference (WACC)

22 Octoober 2024 - Rangsit University, Bangkok, Thailand



WACC 2024: Strengthening Global Integrity Through Collaboration and Innovation



Prominent guests came together to officially inaugurate the World Anti-Corruption Conference 2024, marking the start of impactful discussions and global collaboration in the fight against corruption.

On 22 October 2024, the World Anti-Corruption Conference 2024 (WACC 2024) successfully convened 200 attendees, including global leaders, policymakers, industry experts, and anti-corruption advocates. Under the theme "Transforming Trust, Eradicate Corruption: A Global Unity for Integrity," the conference served as a vital platform for advancing international dialogue, fostering cross-sector collaboration, and showcasing innovative anti-corruption strategies.

Key discussions focused on empowering SMEs in the fight against corruption, enhancing cross-border cooperation in Asia Pacific, strengthening legal frameworks and judicial independence, and leveraging technology to detect and prevent corruption. Experts emphasized the need for harmonized policies, increased transparency, and stronger enforcement mechanisms to drive meaningful change.

The conference concluded with a renewed commitment to global integrity, accountability, and collaboration, reinforcing WACC's role as a cornerstone for shaping anti-corruption efforts worldwide.

Empowering SMEs In The Age Of Globalisation: Strategies To Combat Corruption

This session underscored the critical role of SMEs in the global economy and the unique challenges they face in combating corruption. H.E Kyaw Win Thein, Commissioner of the Anti-Corruption Commission of Myanmar; Mr. Ade Juang Nirboyo, Legal Bureau, Corruption Eradication Commission (KPK), Indonesia; Prof. Dr. Prasit Aekaputra, Senior Professor of the Faculty of Law at Rangsit University, Thailand; Mr. Ang Yuit, President of the Association of Small & Medium Enterprises and Managing Director of The Adventus Consultants Pte Ltd; YBhg. Tan Sri Abu Kassim bin Mohamed, Former Chief Commissioner of the Malaysian Anti-Corruption Commission (MACC); and Dr. Nidawan Pawcsuntorn, Vice Dean for Academic Affairs of the Faculty of Law, RSU shared their insights on the importance of tailored compliance frameworks, enhanced access to resources, and stronger public-private collaborations to support SMEs in implementing effective anti-corruption measures.

Cross-Border Anti-Corruption Efforts In Asia Pacific: Enhancing Regional Cooperation

This discussion reinforced the urgent need for stronger regional collaboration in the fight against corruption across Asia Pacific. Mr. Greco Antonious Beda Banta Belgica, Former Chairman of the Presidential Anti-Corruption Commission, Philippines; Mr. LAU Chi-ho, Paul, Assistant Director of the Operations Department, Independent Commission Against Corruption, Hong Kong, China; Dr. Thanes Sucharikul, Faculty Member of the School of Law of Rangsit University, Thailand; and Dr. Sutthi Suntharanurak, Advisor at the State Audit Office of Thailand shared their expertise on the importance of harmonizing legal frameworks, increasing intelligence-sharing, and strengthening regional anti-corruption networks. Case studies from successful cross-border initiatives were presented, providing valuable insights into best practices for cooperation.

Strengthening Anti-Corruption Legislation And Judicial Independence: Building A Robust Legal Framework

Discussions in this session focused on the urgent need to strengthen anti-corruption laws and ensure judicial independence to uphold the rule of law. H.E Kyaw Win Thein, Commissioner of the Anti-Corruption Commission of Myanmar; Mr. Ade Juang Nirboyo, Legal Bureau, Corruption Eradication Commission (KPK), Indonesia; and Prof. Dr. Prasit Aekaputra, Senior Professor of the Faculty of Law at Rangsit University, Thailand shared their insights on existing legal gaps and highlighted cases where strong legal frameworks have successfully deterred corruption. There was broad agreement on the need for greater political will, increased protection for whistleblowers, and judicial reforms to prevent undue influence.

Leveraging Technological Solutions To Detect And Prevent Corruption

This session explored the transformative role of technology in combating corruption, showcasing innovations such as blockchain, artificial intelligence, and big data analytics. Ms. Moon Sohee, Deputy Director of the Anti-Corruption and Civil Rights Commission of Korea; Dr. Sirilaksana Khoman, Vice Chair of the Foundation for Public Policy and Good Governance (PPGG) and Former Advisor to the Commissioner and Chair of the Economic Sector Corruption Prevention at Thailand's National Anti-Corruption Commission (NACC); and Mr. Krisda Saencharoensap, Director of the Master of Laws (LL.M), Faculty of Law, Rangsit University presented real-world applications of these technologies in strengthening transparency, automating processes, and minimizing human discretion in governance. Discussions highlighted the need for digital literacy, regulatory support, and secure infrastructure to maximize the impact of technological solutions.

Panel Discussion 1: Agricultural and Halal Trade: Exploring Opportunities and Partnerships

On the first day of the Inter-Regional Business Forum (IRBF) on March 7th, 2024, a compelling panel discussion titled 'Agricultural and Halal Trade: Exploring Opportunities and Partnerships' was held, where the complexities of international trade, particularly focusing on agriculture and the halal industry, were navigated. Under the expert moderation of Mr. Fazil Irwan, Director of Communications of Penang Institute (Certified Halal Officer & Former CEO of Penang Halal International), the session saw participation from esteemed panelists including Mr. Alejandro Nervegna, Director of Goods Export Promotion from Argentina's Ministry of Foreign Affairs, International Trade and Worship; Mr. Mohamad Romzi Sulaiman, Senior Manager at Halal Development Corporation Bhd (HDC) from Malaysia; and Mr. Erick Aponte, Trade Commissioner for ASEAN at the Peru Export and Tourism Promotion Board (Promperu). Under the guidance of an experienced moderator, Mr. Fazil Irwan, Director of Communications of Penang Institute (Certified Halal Officer & Former CEO of Penang Halal International), and with contributions from respected panellists, including Ms. Natalia Arcos from Chile's Export Promotion (PROCHILE), Ms. Ezzwanee Ahmad from Malaysia External Trade Development Corporation (MATRADE), Mr. Alfonso Soria from Colombia's ProColombia office in India, and Ms. Rita E-mei representing the Brazilian Trade and Investment Promotion Agency (ApexBrasil) office in Beijing, this discussion initiated a productive dialogue. It paved the way for impactful collaborations and offered valuable insights for sustainable business growth.

Panel Discussion 3: Connectivity: Enhancing Logistics and Infrastructure for Trade Excellence

On March 8th, 2024, the Inter-Regional Business Forum (IRBF) delved into the crucial realm of Connectivity: Enhancing Logistics and Infrastructure for Trade Excellence, marking its second day. 

4th Malaysia Tax Policy Forum: Bridging the Taxation Divide: Building a Sustainable Future for Malaysia

The 4th Malaysia Tax Policy Forum, held on 11 June 2024, and themed "Bridging the Taxation Divide: Building a Sustainable Future for Malaysia," successfully convened experts, policymakers, and stakeholders to explore the intricacies of Malaysia's tax policies. Building on the momentum of previous forums, this year's event focused on critical topics such as the recent Sales & Service Tax (SST) rate increase, its implications for businesses and consumers, and the potential reintroduction of inheritance tax. These discussions were pivotal in addressing crucial aspects of wealth distribution and fiscal sustainability within the Malaysian context.

In addition, the forum tackled the challenges and opportunities presented by digital transformation, particularly the implementation of e-invoicing and its impact on real-time tax reporting requirements. Another significant topic was the introduction of a 10% sales tax on Low-Value Goods (LVG) imported into Malaysia, prompting a comprehensive evaluation of its effects on e-commerce, consumer behavior, and the competitive landscape for local businesses. Moreover, discussions on global taxation and transfer pricing underscored the forum's commitment to aligning Malaysia's tax policies with international standards, ensuring competitiveness and compliance in an increasingly interconnected global economy. Through these insightful discussions, the forum aimed to balance enhancing government revenue with safeguarding consumer interests, fostering a dynamic exchange of ideas to guide Malaysia's tax policy towards greater equity, efficiency, and growth.

Panel Discussion 1: Embracing E-Invoicing: Catalyzing Malaysia's Digital Tax Revolution

The implementation of mandatory e-invoicing in Malaysia marks a significant milestone in the country's tax administration. This session delved into the multifaceted implications of adopting e-invoicing across various sectors, including its impact on business operations, tax compliance, and overall economic efficiency. Experts explored how e-invoicing aligns with Malaysia's broader digital transformation goals and its potential to drive innovation in tax administration processes. The discussion covered technical aspects of e-invoicing implementation, regulatory compliance, and data security, providing a comprehensive understanding of the digital tax revolution underway in Malaysia.

Panel Discussion 2: Tax Transparency: Facilitating Accessibility and Openness of Information on Tax Policies, Obligations, and Practices in Malaysia

Tax transparency is essential for fostering trust in the tax system, promoting compliance, and ensuring equitable tax policies. This session emphasized the importance of providing clear and accessible information to taxpayers and stakeholders to enhance accountability and reduce opportunities for tax evasion and avoidance. Discussions included measures to increase corporate tax transparency, such as country-by-country reporting by multinational corporations. The panel also highlighted the significance of international cooperation in promoting tax transparency and combating tax evasion and avoidance through initiatives like the Common Reporting Standard (CRS) and Base Erosion and Profit Shifting (BEPS).

Panel Discussion 3: Reflection on the Impact and Implications of Taxation on the Economy

This session provided a thorough analysis of recent and proposed tax reforms in Malaysia, examining their combined impact on the economy. Topics included the ripple effects of the recent Sales & Service Tax (SST) rate increase from 6% to 8%, the introduction of a 10% Sales Tax on High-Value Goods (HVG), and the complexities of Transfer Pricing Documentation (TPD) mandated by the new Income Tax (Transfer Pricing) Rules 2023. The discussion also covered the proposed implementation of Capital Gain Tax (CGT) on unlisted shares, assessing its potential ramifications for various entities and investment landscapes.

Panel Discussion 4: Examining the Tax Policies of Tomorrow

Focusing on future tax policies, this session explored the balance between revenue generation, economic growth, and fiscal responsibility. Emerging trends such as Technology and Digital Economy Taxation, Environmental Taxes, and Wealth and Inequality Taxes were discussed, alongside globalization and international taxation. The panel examined the implications of the OECD's Two-Pillar Solution endorsed by 136 OECD/G20 members, with Pillar One aiming for equitable profit distribution and Pillar Two establishing a global minimum corporate tax rate. Malaysia's adoption of the OECD's Globe Model Rules and Domestic Top-Up Tax from January 2025 was highlighted as a significant shift in the tax landscape.

Emphasising the importance of preventing corruption and enhancing governance, he highlighted the successful implementation of 62% of initiatives under the expiring National Anti-Corruption Plan 2019-2023 (NACP 2019-2023). He underscored the significance of forums like WACC, stating, "Conferences like WACC are crucial as each panel shares its experience and best practices in tackling corruption."

Panel Discussion 1: Law Enforcement on Prevention and Persecution

Panel Discussion 3: Preventing the Misuse of Laws to Evade Accountability

Speakers were Mr. Eduardo Valera Bringas, Former Deputy Director General of the Anti-Red Tape Authority (ARTA), the Philippines; Mr. Haji Jais Abdul Karim, President of Malaysia Corruption Watch (MCW), Malaysia; and Dr. Chanroeun Pa, President of the Cambodian Institute for Democracy (CID), Cambodia. They delved into strategies for preventing legal manipulation and enhancing accountability in legal systems.

Panel Discussion 4: Combating Government Corruption - Ensuring Accountability for Clean Governance

The final panel featured Prof. Vicha Mahakun, President of The Anti-Corruption Foundation, Thailand, and Mr. Tsutomu Hiraishi, Committee Officer at the Anti-Bribery Committee Japan (ABCJ), Japan. The discussion focused on the judiciary's critical role in combating corruption and ensuring government accountability.

The conference concluded with closing remarks from Mr. CY Cheah, ISI's chairman, and Dr. Nurul Ghufron, Vice Chairman of Indonesia's KPK. Dr. Ghufron highlighted the WACC's role in facilitating the exchange of views and best practices in combating corruption, underscoring the importance of learning and collaboration.

The discussions emphasized the need for global cooperation and robust and transparent governance systems. Participants left with new insights and strategies, poised to effect positive change in their nations.

3rd Malaysia Tax Policy Forum (MTPF)

3rd Malaysia Tax Policy Forum (MTPF)

The 3rd Malaysia Tax Policy Forum was held on 1 August 2022 (Monday) at The Everly Hotel Putrajaya. With this year's theme, "Reinforcing Malaysia's Ultimate Pecuniary Resilience", the Forum focused on bringing all of these concerns to light, allowing us to identify the most effective ways of strengthening economic recovery, rebuilding national resilience, and catalysing changes.

Besides, the Forum was well attended with about 250 participants from the government, private sector, academia, and NGOs. The Forum was officiated by YB Datuk Mohd Nizom Bin Sairi, Chairman Executive Officer, the Inland Revenue Board of Malaysia (LHDN).

Concerns about Malaysia's restricted tax base have grown more serious since the Goods and Services Tax (GST) was replaced by the Sales and Services Tax (SST) in 2018. According to Malaysian Rating Corp Berhad (MARC), after the reversal, direct tax rates did not rise to pre-GST levels as the indirect tax base fell. To accomplish this, the government said that it would maintain an expansionary fiscal policy, which resulted in a record-high budget of RM332.1 billion, including a larger allocation of RM75.6 billion for gross development expenditure.

3rd Malaysia Tax Policy Forum (MTPF)

Budget 2022 included many additional taxes to restore the government's dwindling funds. In addition, initiatives aimed at increasing tax revenue were proposed as part of the 2022 budget. Corporate income tax collection is estimated to climb by 8.1% to RM65.5 billion in 2019, above pre-pandemic levels. This is encouraging, but it remains difficult because many firms are still attempting to recover from Covid-19. The COVID-19 crisis has significantly weakened state finances, necessitating a rethinking of tax and spending policies once the recovery is well established.

Containment measures, greater government spending, and fewer tax collections have increased budget deficits and government debt, which have reached their highest levels in decades as a proportion of GDP. Former Menteri Besar of Perak, Prof Adjung Dato' Seri Diraja Dr. Zambry Abdul Kadir, delivered a closing keynote address at a forum. He highlighted the forum's purpose, which is to gather opinions for formulating the 2023 Budget. Dr. Zambry also addressed the topic of political financing, mentioning that the BN (Barisan Nasional) has initiated the process of introducing a Political Funding Bill.

3rd Malaysia Anti-Corruption Forum (MACF)

The forum's sessions delved into four key areas:

Panel Discussion 1: Integrity As The Basis For Good Governance.

Explored the foundations of good governance with insights from distinguished speakers Saut Situmorang (Former Deputy Head of Indonesia Anti-Corruption Commission (KPK)) and Nattachak Pattamasingh Na Ayuthaya (Commissioner, National Anti-Corruption Commission (NACC) Thailand). The panel delved into the economic dimensions of corruption, emphasizing the need for collaborative anti-corruption initiatives that addressed root sources, fostering a system of strong, balanced institutions.

Panel Discussion 2: Restoring Trust By Collective Action - Civil Society Perspectives.

Gain perspectives on rebuilding trust through collective action from notable speakers Mohamed Azmi Abdul Hamid (Council Committee Member, Consumers Association of Penang (CAP)), Dato' Sri. Ayub Yaakob (Senior Vice Chairman, Malaysia Crime Prevention Foundation (MCPF)), and Cynthia Gabriel (Founder, Centre to Combat Corruption and Cronyism (C4)). Discussed additional anti-corruption measures and highlighted civil society's role in supporting government efforts.
